4. TREASURERS REPORT

Treasurer Report AGM 2023

IC referred to the submitted report from LB and confirmed that the accounts had now been verified independently. The concerns raised by LB regarding the high costs of the National County Team Championships is notes and will be considered by the Management Board.

5. RESERVES POLICY







The Management Board recommend the adoption of the following policy regarding the maintenance of minimum funds.

Policy

The county wishes to ensure that it maintains a minimum level of reserves to allow it to continue supporting its clubs and members through it key functions including —

- Providing county competitions
- Support through funding for training of volunteers
- Supporting the county team attending the annual national county team championships

The minimum cash reserves the county wishes to have in place are £12,000.

This figure is based on the following -

- County has no fixed assets
- County has limited stock and debtor levels
- Allows the county to cover up to 6 months expenditure without any additional income being received.

Adoption of the policy was approved unanimously.

6. AGREE AUDITOR OF ACCOUNTS

It was recommended that Alison Ayers be approved as the verifier of next year's accounts.

20. PRESIDENTS REPORT

The past year has just flown by. It only seems like yesterday that I took on the honour of County President for 2023.

I would like to start by mentioning Dave Robinson who sadly passed away during the year. Dave was one of the first swimming officials who helped me a lot when I first started officiating in the sport. Dave was always a fixture in my time and greatly missed.

During the year aimed to visit several of the pools that I haven't been to since my own daughters swimming days and register my first visit to Ponds Forge in Sheffield.

In January I made the trip up the A140 to the UEA Norwich for the County 800m and 1500m events. I've always admired the young swimmers tackling the long distance events and the County Long Distance Championships was no exception.

The County Championships at Crown Pools is always a highlight in the swimming calendar, and this year, as all previous years, provided excellent competitive swimming. This was the first year with the new pool layout which provided a few challenges but, as always, a great three weekends of swimming.

The Swimability Gala at Lowestoft in April was a fantastic opportunity for swimmers with disability challenges and I enjoyed the evening so much I plan to attend future galas. A special mention for Ann Byrne for the fantastic work she puts into running the gala. The gala was also attended by a GB para swimmer who was in great demand for photos.

It was an absolute pleasure to attend the Dave Robinson Memorial Gala in June to present a County Award to Jemma Garry. The gala was very well attended at the Mildenhall Hub, a venue which was a first time visit for me. It was nice to see teams from clubs outside our normal catchment which again reminded me of galas I used to attend many years ago.

I attended the Regional Masters at Newmarket in September and had the pleasure of handing out all the medals during day. It dawned on me just how long I've been involved in swimming when I'm handing a medal to my own daughter for masters swimming!

The highlight of my year must go to the National County Team Championships. My very first visit to Ponds Forge. Unfortunately it clashed with the County Development meet at Crown Pools, but I'm thankful to Mark from Newmarket for coming over to Ipswich which enabled me to travel to Sheffield on the Sunday. I thoroughly enjoyed the day and although Suffolk were disappointed in being relegated from Division 1 at the end of the competition, the competition was tough with the swimming of an extremely high standard. The team can be very proud of themselves.







I also attended several galas at Crown Pools and an Open Meet at the UEA Norwich during the year, and was asked by Team Ipswich to present an award to Dave Champion to mark 35 years as Head Coach at the club.

I think that's it, it just remains for me to wish the 2024 President, Peter Elmer best wishes for the coming year and hope he enjoys the year as much as I have done in the past year.

All appointments were agreed and the Presidential chain of office was presented to Peter Elmer by John North.

21. ANY OTHER BUSINESS

DG reminded the meeting that after the closure of Sudbury Swimming Club the club representatives were keen on donating something that would act as a reminder of the history of the club. For various reasons the original idea of donating a new presidential chain had proven difficult. It is now proposed that trophies for the top male (open) and top female Masters swimmer be donated to be awarded at the County Masters event. The trophy would also recognise the contribution made by David Robinson to Masters swimming in the county. The proposal was supported by BW and by all attending.

RG mentioned that the Club were experiencing problems appointing a Head Coach. Many other Clubs confirmed that they were experiencing similar problems.

SE mentioned that she had been approached by an alternative hoody provider. They provide an online service which would make administration much simpler. It was agreed that this option would be considered.
