#### 8. AOB:

AB asked if the provisional date for the Swimability Meet could be confirmed. IC confirmed that this date would be added to the calendar and if possible, this date would be avoided when setting the League dates.

IC confirmed that the provisional dates for the Suffolk League will be 13 April, 18 May and 29 June. These will be confirmed once the Regions dates are known.

DG expressed her concerns regarding the incorrect emails that were sent to a large number of members by Swim England. IC advised that Swim England were aware of the issue and are carrying out a thorough review of procedures and the membership system.

CCo asked if there was to be any changes to coach/team manager ratios. IC stated that the guidance was being looked at by Swim England.

JN reported that the starting system at the Crown Pools was old and problems have been experienced recently. There is no spare available and we could be without AOE if it failed during a competition. The cost of a new starting box is believed to be circa £2,500. JN to obtain quotes so that a decision on whether to purchase can be made.

CV advised the meeting that he had informed members of the East Region County Forum that he had decided to stand down from the position of Chairman of the group.
